## Service Coordination

Service Coordination is a process that develops and carries out plans for children, individuals, and families who have complex needs. A facilitator works with your family to develop a team. This team will develop a service coordination plan that meets at least quarterly to update progress. The Service Coordinator will make monthly contact with your family and help by providing service coordination and services.

### **Service include:**

- Referral to additional support who are not involved with child/family
- Referral for respite
- Referral for family support activities and assistance in paying for these services
- Parenting education
- Transportation (bus tokens, gas voucher)
- Social/recreational activities and Safety and adaptive equipment
- Parent advocacy/mentoring

## High~ Fidelity Wraparound

High Fidelity Wraparound is a family driven process that provides structured, creative and individualized planning for your family with multiple and/or complex needs that require a safety plan and/or and crisis plan.

The objective of Wraparound is to help each family create a team that can help identify needs; plan, deliver services, and support to meet the needs and achieve stabilization.

These meeting happen as much as the family needs support which could be weekly until crisis stabilization is made.

The family is in control of the services they receive. They have a voice in the development of the plan. The plan is updated at least monthly and the outcomes are measured and evaluated.

**\*Service Coordination and High Fidelity Wraparound services are available to all families in Greene County regardless of income.**

## WHAT TO EXPECT:

A facilitator will schedule a time to meet with your family to discuss concerns you would like addressed by the team. They will also help you develop a list of people that should be on the team which will include formal supports such; therapist, teachers, case managers and other professionals, natural supports which include family members, neighbors and friends and informal supports like coaches and church members). After the initial plan is developed the team will meet regularly to review the plan's objectives and strategies and will make revisions as needed.

### **Criteria:**

-Youth living in own home involved with addiction, mental health, children services, juvenile justice or experiencing school failure due to serious behavioral or emotional disorders, as well as youth who are homeless or at risk of becoming homeless.

-Parent/Guardian ACTIVELY involved and voluntarily seeking services.

-Youth whose guardians might otherwise relinquish custody to obtain the needed level of service.

-Youth deemed unruly/delinquent, allegedly unruly, or at-risk of becoming
